## WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in the

Germantown Charity ("Event") and USEF sanctioned or approved event(s) or activity(ies), including but not limited to equestrian clinics, practices, shows, competitions, and related or incidental activities related to or in preparation for the Event ("USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at [www.usef.org](http://www.usef.org), as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any Event and/or USEF Events involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the Event and/or USEF Events organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the Event and/or USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any Event and/or USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at the Event and/or USEF Events.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in the Event and/or USEF Events, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event and/or USEF Events participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event and/or USEF Events owner, licensee, and competition managers; the promoters, sponsors, or advertisers of the Event and/or USEF Events; any charity or other beneficiary which may benefit from the Event and/or USEF Events; the owners, managers, or lessors of any facilities or premises where the Event and/or USEF Events may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (Individually and Collectively, the "Released Parties" or "Event Organizers"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the Event and/or USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

**I HAVE CAREFULLY READ THIS DOCUMENT IN ITS ENTIRETY, UNDERSTAND ALL OF ITS TERMS AND CONDITIONS, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AS WELL AS A HOLD HARMLESS AND INDEMNIFICATION OBLIGATIONS.**

By signing below, I (as the participant or as the Parent/Legal Guardian of the minor identified below) hereby accept and agree to the terms and conditions of this Agreement in connection with my (or the minor's) participation in the Event and/or USEF Events. If, despite this Agreement, I, or anyone on my behalf or the minor's behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities as the result of such claim.

# H/J RULES AND REGULATIONS

## ENTRIES

Entries close June 1, 2024. **Entries submitted after this date will be assessed a late entry fee.** Every Exhibitor, rider, driver, handler and trainer or his/her agent(s) must sign an entry blank. In the case of a rider, driver or handler under the age of 18, a parents or guardian must sign an entry blank on the minor's behalf. Post entries will be accepted with an additional fee of \$50.00. Stall fees must accompany entry to insure reservation. Each entry will pay the USEF fee of \$23.00 (Drugs/Medications fee \$15.00/USEF Federation fee \$8.00), \$7.00 USHJA Fee & \$30 schooling fee and a \$20 night watch fee. A \$50 NSF check fee will apply to all accounts paid with a check that bounces. Checks payable to **GCHS, Inc.**

**REFUND POLICY:** After an entry is submitted, stall fees will be charged even if a horse is scratched. There will be a scratch fee equal to the office fee for any entry scratched after the entry has been accepted.

**There will be a \$50 close out fee for all those entries not closed out by trainer or exhibitor.**  
**A 4% convenience fee will apply to all card charges.**

## USEF/USHJA CREDENTIALS AND MEASUREMENT CARDS

All participants must be able to provide current membership or proof of USEF show pass fee paid. Amateur certification for A/O and Adult Am. Classes, as well as measurement cards for Junior Hunters and Pony Hunters must be available to the horse show secretary before numbers will be issued.

All horses competing in Federation non-breed restricted licensed competitions with hunter, hunter breeding, jumper and hunter seat equitation classes (exception: costume entries, opportunity and lead line entries) must be properly registered with USHJA at USHJA.org. Animals without a current valid measurement card issued by USEF must be measured by the show steward, each day @ approx. 10:00am.

## NON-SHOWING HORSE FEE

A non-showing fee of \$150.00 will be charged for each horse, pony, mule, etc. stabled on the grounds and not in competition in **a complete division**. Non-showing horses must be listed on a completed entry blank.

## EXHIBITOR PASSES

No more than 1 parking and 2 exhibitor passes provided per entered horse or pony. Additional passes will be available in the horse show office at a cost of \$5.00 per exhibitor pass and \$10 per parking pass.

## COGGINS TESTS & HEALTH CERTIFICATES

A Current negative Coggins Test certificate dated within one year must be submitted **ON PAPER** as well as **current veterinarian practice health papers noting Equine Influenza Virus and Equine Herpes Virus vaccination** within 6 months of the competition. If your animal's vaccinations were not administered by a veterinarian, you must, if asked be able to provide to secretaries, a receipt for purchase of vaccines, signed by the owner or agent with control of the animal; name, serial #, expiration date and date of administration.

## STABLING

Permanent stabling of 260 stalls and additional tents are on the show grounds at a cost of \$210.00 per stall. All stalls are approx. 10x10 w/doors. Stall floors might be packed limestone, rubber mats or grass, depending on stall locations. All stall doors are provided. Stabling is available on a first-come, first-served basis.

Management reserves the right to close entries. ***SHIP-IN ENTRIES for showing out of your trailer is not allowed due to space restrictions.*** All showing horses will be charged an entire stall fee regardless of sharing space. Horses may not share stall fees. Additional stalls are also available during the show at the Shelby Show Place Arena. Sharps containers will be provided for all barns and tents. Improper use of or disposal of sharps will result in fines, per USEF rules.

### HORSE SHOW OFFICE

The Horse Show Office will be open by 8:00 a.m. the day prior to the start of the show for processing entries. The office will open approx. 1 hour prior to the start of the show each day. Numbers will not be issued without open check or credit card on file. **4% convenience fee** for accounts closed with any credit card type.

### RV PARKING

RV Parking is available at a rate of \$300.00 for the entire show or any portion of the show. Space is limited. RV spots must be reserved **BY EMAIL WITH BARNEY MALLACE at: BMallace3000@gmail.com**. RV Registration card must be picked up in show office and displayed in a location visible from outside the trailer. **Please do not show up with your camper if you do not have a reservation!** Additional camper spaces may be available at the Agri-Center's Show Place Arena - 901-378-7470.

### SCHOOLING, WARM-UP AND MEDIC

For the convenience of exhibitors schooling will be allowed throughout the day on Monday, beginning at 10:00 A.M. All entered horses will be required to pay the \$30.00 schooling fee and \$20 medic fee. Approved hard hats must be worn with chin-straps fastened. No poling or offset oxers will be allowed at any time.

### CLASSES

Management reserves the right to limit entries, alter courses; prohibit or disqualify exhibitors; change, cancel, limit or combine classes at its discretion to compensate for excessive or inadequate entries or due to acts of nature, without claim for damages.

### OFFICIALS

The show committee reserves the right to substitute a show official in the event of failure of an advertised show official to attend this show or perform his/her duties.

### HEADGEAR / HARD HAT REQUIREMENTS

It is compulsory for all persons at Federation licensed hunter, jumper, or hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. Exception: In Hunter or Jumper classes, adults may be allowed to remove their headgear while accepting prizes and during the playing of the National Anthem only; they must refasten their headgear prior to the lap of honor. It is compulsory for riders in Paso Fino classes, both open and breed restricted including Hunter Hack, where jumping is required and when jumping anywhere on the competition grounds to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. A Show Committee, Competition Management, and Licensed Officials must bar riders without protective headgear from entering the ring for classes in which protective headgear is required and may bar any entry or person from entering the ring if not suitably presented to appear before an audience.

### FOOTING

All show, warm up rings and lunging areas are made of all-weather footing of sand and limestone screenings. Arena dimensions as follows: Main arena-130'x250', North arena-112'x215', South arena-120'x224'.

### TROPHIES, RIBBONS AND PRIZES

A trophy and ribbons 1st – 8th will be awarded in all classes unless otherwise specified. Prize money will not be credited to exhibitor's account without a valid Social Security number. Refunds and additional prize money, if owed will be mailed within 30 days of the completion of the show.

### HUNTER AND JUMPER CHAMPIONSHIPS

Hunter Championships & Jumper Championships will be awarded based on points won in classes throughout each section. Trophy presentations will follow all classes in the main arena.

### COURTESY CIRCLE / JOG POLICY

In all Hunter classes, a dotted line for your courtesy circle may be put into effect at Management's discretion. Rated hunter classes that require jogging for soundness will use a trotted circle at the end of each o/f round.

### JUMP ORDER

A rotating jumping order will be established and posted for all jumper classes. All horses must be ridden in the posted order. Riders and trainers who have conflicts due to multiple entries in a class must see the starter so that necessary adjustments can be made.

### DOGS

Germantown has a strict "Leash Law", and unleashed dogs are subject to impoundment and their owners fined. Loose dogs that are a problem, especially if caught in any arena will cost exhibitor \$100.00.

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) lead line; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes

## **SAFESPORT REMINDER:**

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. ## **MOTORIZED VEHICLE STATEMENT**

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**Open to all riders and horses. Ponies may not compete. The same rider must compete in both phases. Cross-entry is dependent on current USEF and USHJA Zone 4 rules. This class will not count toward any USEF National or Zone awards.**

#### ***Part A. Classic Hunter Style Round***

1. A minimum of ten (10) obstacles will be offered in the Classic Hunter Style Round.
2. Fences will be set at 3'3" to 3'6" in height.
3. Course to include at least one In & Out, one Bending Line and one fence with a long approach.
4. Jumps: Typical hunter-style jumps to be used in this round.
5. Points awarded for placings 1<sup>st</sup> – 12<sup>th</sup> as follows: 26-22-20-18-17-16-15-14-13-12-11-10.

#### ***Part B. Jumper Speed Round***

1. The top twelve horses from the 1st round will be eligible to return for the Jumper Round.
2. This phase to be conducted under Table II.1 – fastest clear round.
3. A minimum of eight (8) obstacles will be offered in the Jumper Speed Round.
4. Fences will be set at 3'6" in height, spreads not to exceed 4'0".
5. Course to include at least 1 combination (double or triple) **and 1 water obstacle.**
6. Jumps: Without a complete transformation of the original Hunter course, typical jumper-style fences with striped rails will be used.
7. Points awarded for placings 1<sup>st</sup> – 12<sup>th</sup> as follows: 26-22-20-18-17-16-15-14-13-12-11-10.

**Overall Awards:** The horse with the highest point total from both rounds will be the winner. Only ties for 1<sup>st</sup> place will be broken with a shortened jump-off course. All other ties will be decided on by the tied horses scores in the hunter round. The tied horse with the highest hunter round score will take the lead (for example: entry #s 227 and 301 are tied for 3<sup>rd</sup> place overall. Entry # 227 had a hunter round score of 80 and entry #301 had a hunter round score of 77 so #227 would end up 3<sup>rd</sup> overall and #301 would end up 4<sup>th</sup>). Overall placings will be 1<sup>st</sup> – 8<sup>th</sup> with prize money distributed as follows:
